

AND,

**RAHUL COLLEGE OF EDUCATION,** hereinafter referred to as **RCE** for brevity's sake, located at Mother Mary's Junior College, Navghar Road, Bhayander (East), Thane, 401105, Maharashtra, India, and represented by its **PRINCIPAL**, **MRS. SANJANA MISHRA**.

**INTRODUCTION:-**

RIMSR is the only affiliate of NEF in India and is legally vested with the authority to represent NEF on all matters and to further the mission and objectives of NEF in India, and abroad. RIMSR is headquartered in Bengaluru, Karnataka, India.

NEF has a legally valid and tenable agreement with the STATE UNIVERSITY OF NEW YORK (SUNY), Potsdam, USA, and SKILLSOFT, USA that permits cooperation and collaboration between NEF, SUNY, and SILLSOFT to further & accomplish the common objective of providing high-quality education/training worldwide and to encourage & promote internationally universities/ institutions to achieve high standards of education/training by accrediting, delivering, evaluating, and certifying academic/ educational/skill programs and making available the above programs to students/youth/ and professionals at the most affordable terms/fee structure.

**RAHUL COLLEGE OF EDUCATION** is one of the leading Colleges in Maharashtra with its parent institution being RAHUL EDUCATION, Maharashtra, India. RAHUL EDUCATION is a conglomerate of over 57+ institutions imparting knowledge in different disciplines, for over 30+years. It proudly boasts of a family that consists of 70,000+ students. RAHUL EDUCATION has come a long way with a deeper vision. It has unfurled great potential through the establishment of the institutions, spread across Thane, Palghar and Pune districts of Maharashtra and Chandauli district of Uttar Pradesh. # NOW, THIS MEMORANDUM OF UNDERSTANDING WITNESSETH AS FOLLOWS: -

In consideration of the conjugation of the mottos of all the parties to this MoU, and in consideration of the benefits that accrue to the above and the society at large, it is agreed to adhere and abide by the terms/guidelines as detailed below:-

- Both NEF-RIMSR and RCE hereon will jointly pursue the mission of "MIG MAKE INDIA GREAT." Under the MIG program, NEF, USA has offered, and the RCE, Maharashtra, India has accepted the following offerings of the NEF, USA for implementation:
- 2. In association with the STATE UNIVERSITY OF NEW YORK at Potsdam, the National Education Foundation at Washington DC will make available 120+ Diploma & Certificate courses in high-demand learning areas at an affordable fee structure to students, and professionals through RIMSR, its only affiliate in India under the aegis of MIG-MAKE INDIA GREAT PROGRAM. The content of the courses is developed & delivered by SKILLSOFT, USA, on a state-of-the-art LMS, and are certified by 'The State University New York at Potsdam, USA', an

- 3. accredited University by the Department of Education, Government of the USA, and the UGC-AIU, Government of India.
- 4. The list of "Job-Ready Courses," and a specimen of the Course Completion Certificate are attached:
  - 1. Job-Ready Courses : Attached Attachment I
  - 2. Post Graduate Diploma Courses : Attached Attachment II
  - 3. Specimen Certificate : Attached Attachment III

While the duration of each "Job-Ready Course" is six months, the coursework of the PG Diploma Courses is twelve months. After the completion of the course work students need to appear for a final examination in the subject of their study.

The examination and grading norms are detailed hereunder:

- All examinations are screen-based consisting of MCQs and short notes. The duration of the final examination is 60 minutes. There will be a separate examination for each course. The date and time of the examinations will be finalized in consultation with RCE. Students are kept informed of the date, and time well before the examination. The grading system is as follows:
  - A grade of 90% (GPA-3.6) & above is rated as an "A" signifying an exceptional, clear, and creative grasp of the concepts of the course with a demonstrated superior ability to apply the acquired knowledge on the job. It also means that the student has actively participated in all the assigned activities and has completed the coursework/assignments on time demonstrating exceptional work, and therefore deemed as passed.

Grading of 95% - GPA of 3.8 and above is rated as an "A+" grade, meaning the student has passed the course with distinction.

Apart from being certified by the State University of New York, a student securing a GPA of 3.8+ on a scale of 4.0 is conferred with the coveted "Appuji Gold Medallion of Merit," an honour in recognition of a student's merit.

A grade of "B" signifies a solid and required understanding of the major concepts of the course and the ability to apply those concepts. It also means that the student's effort and participation have exceeded the minimal basic requirements for the course. All assignments are judged to be solid in content and completed on time. This is deemed to be the minimum criteria acceptable. Grading of 60% (GPA-2.4) up to 89% (GPA-3.56) is rated as a "B" grade, meaning the student has passed the course.

A grade of "C" signifies a below-average demonstration and application of the concepts of the course and/or inadequate preparation in-class activities. It may also indicate that assignments were not completed in a satisfactory or timely manner. Grades below 60% (GPA-2.4) are rated as "C" and are deemed to have failed.

However, the failed students are eligible to repeat the coursework without any additional fee, subject to prior approval of NEF-RIMSR. Such a provision to reappear for the examination is available twice.

- 5. The "course fee" under this MoU under the aegis of the MIG-MAKE INDIA GREAT PROGRAM, is as below:
  - 1. Job-Ready Courses: Rs. 5,000 per Course + GST
  - 2. Post Graduate Diploma Courses : Rs. 75,000 per PG Diploma + GST

- 6. The "course fee" includes tutorials, reading materials, exams, and certifications.
- 7. RCE is eligible for 10% of the "course fee" to meet their expenses/margins.
- 8. However, RCE is permitted to give additional value-added services to the students and top-up their charges for such additional services and fix the "end-user fee" payable by the students. Under any circumstances the "end-user fee" should not exceed double the "course fee" as given above.
- 9. RCE will collect the "course fee" as invoiced by RIMSR from the students enrolling to the "Job-Ready Courses," deduct at source 10% of the "course fee" amount and transfer the balance fee amount to RIMSR within 24 hours from the date and time the "course fee" is collected.
- 10.The "course fee" as above is payable to the RANGNEKAR INSTITUTE OF MANAGEMENT STUDIES AND RESEARCH, BENGALURU, KARNATAKA, INDIA to the following account:

- 11.Only upon receipt of the "course fee," the licenses to the courses will be issued by RIMSR to RCE. In turn, the licenses to the students enrolled in the courses will be made available by RCE. The period of validity of the licenses is twelve months from the date of enrolment.
- 12. The fee structure is subject to change and the participating institution will be kept informed three months in advance about the changes to the fee structure if any.
- 13. With the objective of motivating students to secure good grades, NEF-RIMSR has instituted "Appuji Medallions of Merit," which is a golden medallion to students securing "A" grade with distinction, that is percentage =>95% or GPA =>3.8, a silver medallion to students securing "A" grade, that is percentage =>90% or GPA =>3.6, and a bronze medallion to students securing a percentage =>80% or GPA =>3.2 in the final examination of "Job-Ready Courses." Students securing less than 60% or GPA of less than 2.4 in the final examination are declared as failed.
- 14.All the expenditure towards marketing and other promotional activities undertaken will be fully met by RCE. No expenditure of any kind will be met either by RIMSR, or NEF, or SUNY, jointly or severally.

- 15.NEF-RIMSR has permitted RCE, MAHARASHTRA, INDIA, to exclusively market the courses of NEF-RIMSR in the state of Maharashtra, India, subject to the condition that the latter will ensure a minimum fresh admission of 200 (+ or 20%) students to the courses of NEF-RIMSR from the state of Maharashtra, India. In case, the RCE finds it unable to source a minimum of 200 (+ or 20%) in a month consistently for a period of three months from the date of this MoU, NEF-RIMSR retains the authority to cancel this clause of giving "exclusive rights."
- 16. For successful implementation of the program, RCE will appoint a 'NODAL OFFICER' who will coordinate all the matters connected with the program jointly with NEF-RIMSR. For this purpose, NEF-RIMSR appoints Ms. Mamata, Deputy Registrar & EA, RIMSR for the smooth and efficient implementation of the MIG program.
- 17. This MoU will be valid for one year commencing from the date of this MoU. The MoU may be extended for a further period by mutual agreement on the terms as agreed upon.
- 18.Both NEF-RIMSR and RCE will endeavour to keep confidential all knowledge, and information they acquire during their association.
- 19.In case of any dispute arising as regards the interpretations of the provisions of this MoU, both parties will resolve the same through mutual discussion. In the event of a failure to resolve, the matter may be referred to arbitration. The Founder-Chairman of NEF, Washington DC, USA, and the Chairman of RAHUL EDUCATION, Maharashtra, India will arbitrate on the matter whose decision will be final and binding on both the parties.

20.However, the spirit of this MoU is to ensure that there shall be no such occasion for dispute and resolution of the same.

### THE PARTIES HEREBY AGREE AS FOLLOWS:

The Parties enter into this MoU for future academic collaboration between the Parties in relation to university research and education. The MoU only contains the general principles for collaboration between the Parties.

In order to accomplish the above goals, the parties shall pursue collaborative activities, including but not limited to:





Best Practices and Benchmarking

- Academic Transfer and Articulation arrangement between the two Universities
- Students & Faculty Exchange Program
- Research Collaboration & Joint Research Projects and Partnering for joint efforts of Grants available for academic support
- Joint Conferences and Publication Initiatives
- Student, Staff and Researcher Mobility's
- Scientific research, lectures, conferences and publications
- Training Programmes and short courses
- Collaboration in different Centers of Excellence
- Other scope of cooperation in fields of interest to both parties

Each individual collaborative project will be planned, developed and executed by the Parties respecting the principles agreed in this MoU and be subject to a separate written agreement to be executed between those parties taking part in such project.

Each Party bears all the charges of its own related activities under this MoU, if not specified differently in further agreements.

This MoU shall be governed by and construed in accordance with the laws of both United Arab Emirates and India.

The Parties tend to solve all the issues to implementation of this MoU by means of consultations.

Any amendments, alterations or additions to this MoU must be made in writing as addendum to this MoU and signed by the duly authorized representatives of the Parties.

This MoU is to be valid for a length of five (5) years. MoU shall be subject to review by both parties by the end of its last month, and may be extended, amended or terminated at that renegotiation.

#### Confidentiality

No rights of any kind whatsoever in any invention, copyright, trade secret, or any other form of intellectual property are granted or transferred under this MoU. Distribution and use of information and intellectual property resulting from the cooperation activities under this MoU are performed in compliance with the existing legislation of the Parties and in compliance with further agreements signed by the Parties.

Any use of the names **'SUC or 'RCOE,** including any of its constituent schools, departments, Programmes or logos, relating in any way to the activities described in this MoU, shall be subject to prior written approval.





All data and information identified as being confidential are considered confidential. The receiving Party shall use diligent efforts to maintain such data and information in confidence, and use only for the purposes contemplated in this MoU.

Both Parties, shall keep strictly confidential all information and materials provided by one Party (the Disclosing Party) to the other Party, pursuant to this Agreement (the Confidential Information) and shall not provide the Confidential Information to any third party without the prior written consent of the Disclosing Party.

This Clause shall not apply to any information which:

- (a) is required to be disclosed by law, pursuant to legal process or by any governmental or competent regulatory authority;
- (b) at the time of its disclosure is or subsequently becomes public knowledge other than by breach of this Agreement; or
- (c) is lawfully received by, is already in the lawful possession of or subsequently comes lawfully into the possession of a Party from a third party who does not owe and is not under any obligation to keep the information confidential.

The provisions of this Clause are binding and shall survive the termination of this Agreement.

Each party shall reserve the right to the intellectual property on studies, research, documents and Programmes of its own, including the right to use them in the method determined by each Party to the other party for such use and its scope. Neither Party, nor any third party, may practice such right without the written permission of the other Party.

This MoU has been executed in two (2) identical copies, one (1) for each Party.
