MEMORANDUM OF UNDERSTANDING (MOU)

Rahul College of Education, a teacher Education College under Shree Rahul Education Society, a TRUST incorporated under the relevant laws of Bombay Public Trust Act 1950, through its authorized signatory, Chairman Shri Lallan R. Tiwari, having its registered office at C/O Mother Mary's Jr College, Navghar Road, Bhayander East. Thane - 401105. (hereinafter referred to as "College" which expression shall unless repugnant to the context, be deemed to include its successors and permitted assigns) of the **First Part**.

And

Sanctum Manpower Consultancy, a company incorporated under the relevant laws of the Indian Companies Act, 1956, through its Director / authorised signatory Mr. Robin Dubey having its registered office at 1st Floor, A107, Shanti Ganga, Station Road, Bhayandar East. Thane – 401107 (referred to as "Sanctum" which expression shall, unless repugnant to the context, be deemed to include its successors and permitted assigns) of the **Second Part**.

Rahul College of Education and Sanctum Manpower Consultancy hereinafter collectively be referred to as the "Parties" and individually referred to as a "Party".

Whereas

1. The parties are interested in working together in connection with the purpose which is prescribed in section 1.
2. This MoU sets out the initial relationship between the parties as well as the respective rights and responsibilities Party.
3. This MoU is not intended to be legally binding but it is intended to document the expectations of each Party except obligations contained in the Clause on Confidentiality which is intended to be binding on the Parties herein.
4. Each Party respectively is expected to act in good faith in accordance with the MoU.

1. Objective and Purpose

- The objective of this MOU is to express the willingness of both parties to engage in a possible association between both parties.
- **Sanctum** intends to partner with **Rahul College of Education** for the following purpose/s:
 - **Sanctum has an existing network of employment opportunities across Mumbai.**
 - **Sanctum to partner with Rahul College of Education to create employment opportunities and assist in up-skilling teachers along with skill gap training as per NEP for pre-service and in-service teachers across Teacher Education colleges in India.**

2. Product & Offerings

Both parties agree to discuss and evaluate each other's proposal in good faith to arrive at a consensus mutually agreeable and move to enter into a legally binding agreement.

- Sanctum will provide details of its various program offerings currently being offered or future offerings. Sanctum and **Rahul College of Education** will work closely to create the courses & curriculum meant for the upskilling of teachers.
- Conduct internship and placement drives/opportunities in various companies from the field of Education for the students of Rahul College of Education

2.2 Rahul College of Education Offerings

- Rahul College of Education along with Sanctum will provide training to teachers and help in the engagement of pre-service and in-service teachers across Teacher Education institutions, schools and colleges in India wherever mutually decided and consented upon.
- Rahul College of Education will develop modules for in-service teacher training programs in association with Sanctum.

3. Changes to Memorandum

This Memorandum may be amended at any time by agreement between the Parties. Any change to this memorandum must be made in writing and signed by the Parties.

4. Confidentiality

Notwithstanding anything contained herein, this "Confidentiality" clause is intended to be legally binding on both the Parties herein.

The Parties each acknowledge and agree that in connection with this Memorandum, they may have access to confidential and/or commercially valuable information to one or more of the other Parties ("Confidential Information").

The Parties each hereby acknowledge and agree that they may be both the receiving Party in relation to some Confidential Information ("Receiving Party") and the disclosing party in relation to some other Confidential Information ("Disclosing Party") and the terms of this Memorandum may apply to a Party as both a Receiving Party and Disclosing Party, as the context so provides.

For the purpose of this Memorandum, Confidential Information may include but is not limited to:

1. Information of whatever nature relating to the Project or to any other Party (Whether relating to the Project or otherwise)
2. Any information derived from any other information which falls within this definition of Confidential Information; and
3. Any copy of any Confidential Information.

In relation to Confidential Information:

1. The Receiving Party shall keep the information confidential and secret.
2. The Receiving Party shall only use the Confidential Information for the purpose of working in good faith on the project in accordance with the Memorandum.
3. The Receiving Party shall not release the Confidential Information to any other party unless that party is an advisor who is under a duty of Confidentiality, is assisting with the Project, and needs to have the Confidential Information in order to assist with the Project.

5. Timing and Duration of Project

1. This Memorandum will commence on 16th January 2022.
2. The Parties will negotiate in good faith in order to sign a final and legally binding agreement in relation to the Project (the "Agreement") on or before 31st December 2022.
3. This Memorandum will remain in effect until the commencement, or unless and until otherwise terminated by the Parties.
4. The parties may terminate this Memorandum by mutual Agreement.
5. Either Party may terminate this Memorandum by providing 30 days' notice in writing to other the Party.

6. Consequence of Termination

In the event that this Memorandum is terminated:

1. Neither party will, under this Memorandum incur any financial liability to the other party and
2. Notwithstanding the preceding sub-clauses hereof, either party may incur liability towards the other party in connection with matters outside of this Memorandum, which may include but are not limited to liability in relation to breach of contract, tort or equity.
3. In the event that a party ("First Part") is in possession of any equipment, materials, documents, intellectual property, data or other information ("Items") that are the property of the other party ("Second Part"), then the First Part must promptly return all items as to the Second Part, or destroy any items if directed to do so by the Second Part; and
4. The obligations provided in the "Confidentiality" clause of this Memorandum will continue for the periods as provided in those clauses.

7. General Terms of MOU

Duration of MOU: This MOU shall be operational upon signing and will have a duration of **24 Months**. All activities conducted before this date within the vision of the joint collaboration will be deemed to fall under this MOU.




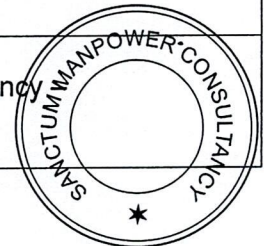
