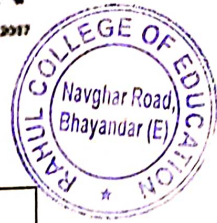


4. Framework for Faculty Research and Publications:
