4	Examinations	 Final examinations planning was explained and as the college is a University Centre, the same was discussed with all Students of RCOE after rigorous remedial lectures and tutorials were confident for the examinations 	
5	NAAC Work Undertaken	 Since the last meetings the NAAC criteria work had progressed substantially and was back on track. Although the faculties proposed that the NAAC Visit/SSR Filling be proposed to a later date. This point was left for discussion as all had different views, and hence no change was bought to the earlier date.
