The active participation of faculty members was acknowledged as crucial in shaping the educational approach during these challenging times. The meeting link was shared over the WhatsApp group for easy access.

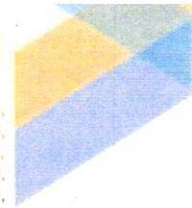
