## Notice No. 2 CAP Round-II B.Ed

- Ref No : Government of Maharashtra Gazette, Extraordinary Part-IV-B, extraordinary No. 113, and Dated 5<sup>th</sup> May 2017.

- ✚ Colleges are requested **NOT** to verify the details filled in CET Application form as it was only for CET Examination. In addition, college should not force the candidate to submit the Hall Ticket of CET Examination.
- ✚ Colleges has to verify the details filled in CAP Application form only.
- ✚ College should not deny or reject the admission of candidates due to non-availability of original mark sheet or certificate for SSC & HSC. College should consider either mark sheet or certificate of SSC & HSC by seeking undertaking that he/she will provide the original duplicate mark sheet or certificate within 15 days.
- ✚ Candidates who have not received the Final Year Degree mark sheet, but their result have been declared in the form of the **"OFFICE RECORD COPY" or "Mark Memo" or "Online Result"** i.e Gazette Copy which contains the marks obtained in each subject & total marks. Candidates should admitted on the basis of such office Record copy/Mark Memo endorsed by concerned Principal/Competent Authority. If Final Year Original Mark sheet is available at the time of Admission, candidate/College should upload it in CAP Form. If Final Year Original Mark sheet is not received then candidate can submit and upload it until the last date of CAP Round III.
- ✚ If marks & percentage of First Year & Second Year are mentioned on the Final Year Degree mark sheet then college should not force the candidate to produce First Year & Second Year mark sheet separately.
- ✚ Candidates admitted in Round-I & Round-II will have to submit & Upload the Original CVC, TVC, NCL & EWS certificate upto the last date of admission of Round-III. (as applicable)
- ✚ SEBC Candidates who have uploaded receipt of CVC will have to submit original CVC within the 6 month from the date of filling the CAP Application form.
- ✚ Submission of Caste Validity Certificate for the period of 6 months is only for SEBC candidates. This due period is not valid for other reserved category candidate.
- ✚ Candidates who have made mistakes in filling the marks of SSC & HSC and have been rejected by the college can edit their CAP Application form for Round III between **01/09/2024 to 03/09/2024** and fill the new college options for Round III.

✚ ICSE or CBSE Board SSC passed candidates who have filled 6 or 5 subject marks shall be considered for admission. College should not reject the admission of such candidate.

**(1) Candidate who are Eligible for Round II: -**

- a) Candidates who have been allotted seat **OTHER THAN FIRST PREFERENCE** and have rejected the Admission OR Refused the Admission OR Not reported to the college OR Not Opted Freeze or Betterment option through candidate's login.
- b) Candidates who have been allotted seat **OTHER THAN FIRST PREFERENCE** and have either paid or not paid the one-time Seat Acceptance fees of Rs. 1000/- & Opted Freeze or Betterment option through candidate's login, but have not reported to college for confirming the admission.

**(2) Candidates who are NOT Eligible for Round II:-**

- a) Candidates who have been allocated college of First Preference and have verified their documents and have been admitted in the college through college log in and paid the college fees will not be considered for allocation in Round II.
- b) Candidate who have been allotted seat other than the **first preference** as per the preference given by the Candidate and freeze the allotted seat by paying seat acceptance fee of Rs 1000/- through Candidate's Login & confirmed admission on the allotted seat through college login. Such admitted candidates are not eligible for Round-II.
- c) Candidates who have allotted college of First Preference as well as other than First Preference and have verified their documents and have been rejected by the Admitting College due to discrepancy in application form, document or mismatch in document and application form are not eligible for allocation in Round II. Such candidates are Eligible to participate for Round-III.

**(3) Application of Logic of Dynamic Allocation For Round-II:-**

- a) Candidates who have been allotted seat **OTHER THAN FIRST PREFERENCE** in Round-I and have Opted Betterment Option and Paid the seat Acceptance fees of Rs. 1000/-, Once upward preference is allotted to such Candidate as per the college Option /preferences filled prior to Round-I, his earlier seat allotment shall stand automatically cancelled due to application of **LOGIC OF DYNAMIC ALLOCATION**.
- b) If the Candidate is not allotted seat in Round II, then the seat already allotted in Round I, as the case may be, shall be retained automatically but the Candidate will have to report to Admitting college or Institute for Confirmation of Admission again for Round - II. Colleges should confirm the Admission of the candidates of Round-II, though they have been allotted same college in Round-I. If the candidate does not report to the college in the specified period, his seat will stand forfeited automatically.

**(4) Caste Validity Certificate/ Tribe Validity Certificate/Non-Creamy Layer certificate & Economically Weaker Section Certificate: -**

- a) Candidates admitted in Round-I & Round-II will have to submit & Upload the Original CVC, TVC NCL & EWS certificate until the last date of admission of Round-III. (as applicable)
- b) The candidates belonging to reserved category who have secured admission on seats for reserved category in Rounds I and II on the basis of application receipt of CVC/NCL/TVC etc. are required to upload the necessary original certificate (CVC/NCL/TVC etc.) on or before the last date of Round III. The candidates who

failed to upload the necessary certificate, their admission shall be cancelled by the college through its login or through online system. These students may apply for the next round from open category, if they meet the requirements and conditions for the open category.

- c) SEBC Candidates who have uploaded receipt of CVC will have to submit original CVC within 6 month from the date of filling the CAP Application form. Submission of Caste Validity Certificate for the period of 6 months is only for SEBC candidates. This due period is not valid for other reserved category candidate.
  - d) If any admitted candidate in Round-I & Round-II wish to participate in Round-III & Institutional Level Round (Round-IV), then he/she will have to cancel his/her earlier admission through college login. Then only he/she will be eligible to participate in the Round-III & Institutional Level Round (Round-IV).
- (5) The candidates who had uploaded receipt of the application of CVC/TVC/NCL/EWS in CAP application form and if have not received the documents then he/she should edit application form to be eligible for allocation through Open category in Round-III & Institutional Level Round (Round-IV) as per the updated schedule displayed on the CAP Portal.
- (6) There may be very few seats available for Round III. Hence, Candidates are requested to seek the admission in the allotted college though the same college is allotted to the candidate in Round II.
- (7) Probability of vacancy for Round III may be very less. Hence, candidates should take a judicious decision for their admission.
