Notice No. 3 CAP Round - III LLB 3 Yrs, B.P.Ed, M.P.Ed, MEd & B.Ed

- ✚ Candidates, who have been allotted college of their 1st Preference either in Round I or Round II but not reported to the college for confirming Admission are not eligible for Round III. Such candidates can participate in Institutional Round (Round IV).
- ✚ Candidates who have been rejected by the college due to discrepancy in the application are eligible to participate for Round-III. Candidate should obtain rejection letter from college & it is the responsibility of the college to provide rejection letter to candidates.
- ✚ If candidate has frozen the admission of Round-I OR round-II but not visited college for admission confirmation & also not paid the college fees & college has not confirmed his/her admission through college login, then candidate has to fill the new college option form for Round-III, as it is mandatory. Then only candidate will be considered for Round-III.
- ✚ If candidate has frozen the admission of Round-I OR Round-II & visited college for admission confirmation & paid the college fees & college has confirmed his/her admission through college login, then candidate will have to cancel the admission of Round-I OR Round-II by sending online request of cancellation of admission. Admission cancellation option is provided in candidate's login. After online request, candidate has to visit the college for admission cancellation. College will cancel the admission of Round-I OR Round-II through their college login. After cancellation of admission, college will give admission cancellation receipt to the candidate. Then only candidate will be able to participate for Round-III. Candidate will have to fill the new college option form for Round-III, then and only then candidate will be consider for allocation of Round-III.

- ✚ Colleges are Informed **NOT** to verify the details filled in CET Application form as it was only for CET Examination. In any case, college will not force the candidate to submit the Hall Ticket of CET Examination. Colleges has to verify the details filled in CAP Application form only.
- ✚ Only Freeze option is available in the candidate's login to "Freeze" the admission of Round-III. Candidate can freeze the allotted seat of round-III by paying the seat acceptance fees of Rs.1000/-. (If Seat acceptance fees of Rs. 1000/- is already paid, then no need to pay it again.)
- ✚ Candidates admitted in Round-I ,Round-II & Round-III will have to submit & Upload the Original CVC, TVC, NCL & EWS certificate (as applicable) till the last date of admission of Round-III. i.e (as per schedule of respective course)
- ✚ Colleges should intimate the candidates to submit & upload the Original CVC, TVC, NCL & EWS certificate, who have been admitted in Round-I & Round-II on the basis of receipt of application to obtain Original CVC, TVC, NCL & EWS certificate (as applicable).
- ✚ VJNT, NT-B, NT-C, NT-D, SBC, SC & ST reserved category candidates who have been allotted college in Round-III in reserved category seat on the basis of receipt of CVC, TVC, NCL & EWS certificate, then college should verify the Original certificates at the time of admission & Upload the same on the portal. Without Original CVC, TVC, NCL & EWS certificate, college should not admit the candidate. Otherwise, college will be responsible for the wrong admission.
- ✚ No candidate is to be admitted without original CVC, TVC, NCL & EWS certificate in Round-III.
- ✚ Only SEBC & OBC Candidates who have uploaded receipt of CVC will have to submit original CVC within the 6 month from the date of filling the CAP Application form. College should admit SEBC & OBC candidates on the basis of receipt of CVC.
- ✚ Submission of Caste Validity Certificate for the period of 6 months is only for SEBC & OBC candidates. This due period is not valid for any other reserved category candidate.
- ✚ SEBC Caste Certificate may be on the same page with NCL Certificate or both Certificate may be separated. Both are valid certificate. College should verify the caste certificate issued as per Government of Maharashtra Gazette, Extra-Ordinary, Part VIII, dated 26th February, 2024, Maharashtra State Reservation for Socially and Educationally Backward Classes Act, 2024.

- ✚ If any admitted candidate in Round-I & Round-II wish to participate in Round-III & Institutional Level Round (Round-IV), then he/she will have to cancel his/her earlier admission through college login. Then only he/she will be eligible to participate in the said rounds.
- ✚ If candidate fails to submit & upload the necessary certificate, within the stipulated time then the candidate's admission shall be cancelled by the college through its login or through online system.
- ✚ These candidates may apply for the Institutional level Round in “OPEN” category, if they meet the requirements and conditions for the open category.
- ✚ If any admitted candidate in Round-I, Round-II & Round-III wish to participate in Institutional Level Round (Round-IV), then he/she will have to cancel his/her earlier admission through college login. Then only he/she will be eligible to participate in the Institutional Level Round (Round-IV).
- ✚ The candidates who had uploaded receipt of the application of CVC/TVC/NCL/EWS in CAP application form and if have not received the documents then he/she should edit application form to be eligible for allocation through Open category in Institutional Level Round (Round-IV) as per the updated schedule displayed on the CAP Portal.
- ✚ There may be very few seats available for Institutional Level Round-IV. Hence, Candidates are requested to seek the admission in the allotted college of Round-III.
- ✚ Probability of vacancy for Institutional Level Round-IV may be very less. Hence, candidates should take a judicious decision for their admission.
