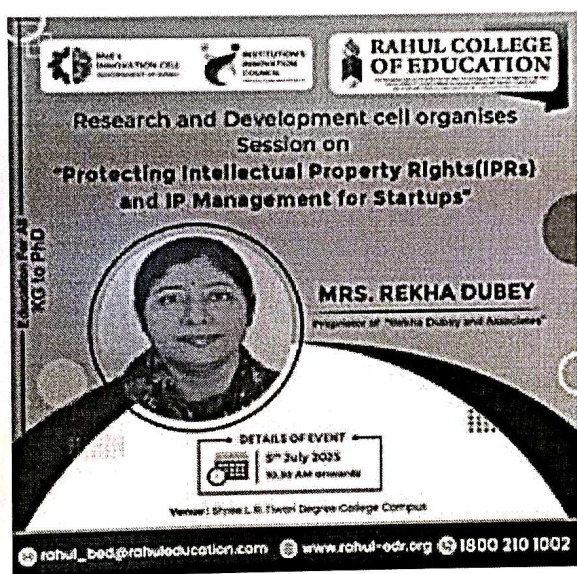
enriched with real-life examples, step-by-step filing processes, and an engaging Q&A session that encouraged audience interaction and deeper understanding.
